1 On February 26, 2020, this Court heard the Motion for Attorneys' Fees, Costs and
2 Incentive Awards filed by Plaintiffs Sheila Linderman and Charles Mayrshon ("Plaintiffs"). This
3 Court reviewed the motion and the supporting papers. As such, having reviewed the foregoing
4 and based on the findings below, the Court found good cause to grant the motion.

5 **FINDINGS:**

6 1. An award of attorneys' fees in the amount of \$991,667.00 is fair and reasonable in
7 light of the nature of this case, Class Counsel's experience, the significant time and efforts in
8 prosecuting this action, and the benefits obtained for the Class members.

9 2. An award of litigation costs in the amount of \$25,579.48 is appropriate as the
10 request reimburses Class Counsel for out-of-pocket expenditures in this case, the expenditures are
11 well-documented, constitute reimbursable costs under the law, and is otherwise fair and
12 reasonable.

13 3. Incentive awards in the amount of \$5,000.00 to the named Plaintiffs are fair and
14 reasonable in light of the risks in commencing this action, and the time and effort spent litigating
15 this action as the Class representatives.

16 **IT IS ORDERED THAT:**

17 4. **Attorneys' Fees and Costs.** Class Counsel are awarded attorneys' fees in the
18 amount of \$991,667.00 and costs in the amount of \$25,579.48, for a total of \$1,017,246.48.
19 Defendant must pay Class Counsel this amount according to the manner and timeline set forth in
20 Paragraph 108 of the Amended Settlement Agreement.

21 5. **Incentive Awards.** Plaintiffs Sheila Linderman and Charles Mayrshon are
22 awarded \$5,000.00 as an incentive awards. Defendant must pay Plaintiffs this amount according
23 to the manner and timeline set forth in Paragraph 103 of the Amended Settlement Agreement.
